

# Privacy Notice for the 'Call for input: single sex spaces guidance' survey

This notice sets out how we will use your personal data, and your rights. It is made under Articles 13 and/or 14 of the UK General Data Protection Regulation (UK GDPR).

# Your data

## Purpose

The responses from the Call for input: single sex spaces guidance will be used to understand how organisations may currently misinterpret the law on single-sex services and spaces.

#### The data

We are not asking for personal data, and we request that you do not include personal data of yourself or others in your responses to the call for input. We recognise, however, that in some cases personal data may be included in responses. For example this could include an individually identifiable name and email address.

## Legal basis of processing

The legal basis for processing any personal data you provide is that it is necessary for the purposes of the legitimate interests pursued by the Cabinet Office. In this case, our legitimate interest is to gain an understanding of policies and guidance given to and issued by public bodies, or other bodies advising public or private sector organisations, on access to single-sex spaces and services by transgender people based on their self-identified gender. This will in turn help us to ensure that our policymaking continues to tackle any confusion and we ensure single-sex spaces are maintained.

# Recipients

We are requesting that you do not include personal data about yourself or others in your responses, such as names and email addresses. However any data you provide will be shared with our online platform provider, and their hosting provider. It may also be stored on our IT infrastructure for analysis. Should we receive, contrary to our expectations, any personal data that is protected information under section 22 of the Gender Recognition Act 2004, we will take appropriate steps to comply with this section.

#### Retention



After the survey, the responses and subsequent analysis will be kept on our corporate IT infrastructure in a non-identifiable format.

# Your rights

You have the right to request information about how your personal data are processed, and to request a copy of that personal data.

You have the right to request that any inaccuracies in your personal data are rectified without delay.

You have the right to request that any incomplete personal data are completed, including by means of a supplementary statement.

You have the right to request that your personal data are erased if there is no longer a justification for them to be processed.

You have the right in certain circumstances (for example, where accuracy is contested) to request that the processing of your personal data is restricted.

You have the right to object to the processing of your personal data where it is processed for direct marketing purposes.

You have the right to object to the processing of your personal data.

### International transfers

Any personal data provided will be stored on our corporate IT infrastructure, and shared with our data processors, it may be transferred and stored securely outside the UK. Where that is the case it will be subject to equivalent legal protection through a reliance on Standard Contractual Clauses, or reliance on a UK International Data Transfer Agreement.

# Complaints

If you consider that your personal data has been misused or mishandled, you may make a complaint to the Information Commissioner, who is an independent regulator.
